Notes to Applicant

Appeals to the Secretary of State

- If you are aggrieved by the decision of your local planning Authority to refuse to discharge the conditions, then you can appeal to the Secretary of State for the Environment under section 78 of the Town and Country Planning Act 1990.
- If you want to appeal, then you must do so before 6 months , using a form which you can get from **The Planning Inspectorate, Registry/Scanning Team, Temple Quay House, 2 The Square, Temple Quay, Bristol BS1 6PN. The appeals Helpline is Tel: 0303 444 5000.**
- The Secretary of State can allow a longer period for giving notice of an appeal, but he will not normally be prepared to use this power unless there are special circumstances which excuse the delay in giving notice of appeal.
